# **BOARD OF COUNTY COMMISSIONERS**

#### **APRIL 18, 2023**

A Board Workshop was held at the Murdock Administration Complex in Commission Chambers; Room 119, Port Charlotte, Florida.

The following members were present: Chair Truex, Commissioner Constance, Commissioner Deutsch, Commissioner Doherty, and Commissioner Tiseo. Also in attendance were: County Administrator Flores, County Attorney Knowlton, Minutes Clerk Johnston, and various County staff members. The following members were absent: None.

The Meeting was called to order at 9:00 am, followed by the Pledge of Allegiance.

County Administrator Flores highlighted Board Workshop.

## 1. Sales Tax Update

Assistant County Administrator Claire Jubb gave a brief overview of 2014 Sales Tax: Completed, Active Projects, 2020 Sales Tax Projects: Tier 1, and Tier 2.

Travis Perdue, Facilities Construction and Maintenance Director gave a brief overview of Placida Boat Ramp Expansion (2014), Supervisor of Elections (2014), Port Charlotte Beach Complex (2020), Port Charlotte Beach Pool (2020 Tier II), Family Services Center — Phase II (2020), Sheriff's Administration Center/911 (2020), Sheriff's District 4 and Training (2020), Fire Stations 3, 6, and 17 (2020), GC Herring Park (2020), and William R. Gaines Jr. Veterans Memorial Park Phase II (2020).

John Elias, Public Works Director introduced Lindsey Johnson, Public Works Project Manager, gave a brief overview of Access Management, Roadway Name, Sales Tax (2014), Edgewater Expansion Design, Sidewalks and Trails Sales Tax (2020), Marathon Boulevard Pathway, Sunset Boulevard, Fruitland Boulevard/Avenue of the Americas Sidewalk, Quesada Boulevard Sidewalk, and replied to Taylor Road sidewalk.

Ms. Johnson gave a brief overview of Edgewater Expansion Design, Project Overview, Pellam Bridge Construction, Access Management, and Roadway Name.

Dave Watson, Utilities Director gave a brief overview of Water Quality Infrastructure Sales Tax (2020) Budget \$7,000,000, Sales Tax (2020): Ackerman Septic to Sewer Project, Lake View/Midway Septic to Sewer Project, Cape Haze Septic to Sewer Project, Water Quality – Vacuum Station – Tier 2 (2020) Budget \$3,000,000, and Midway North Septic to Sewer Project.

Chair Truex commented on Fire Stations 3, 6, and 17 (2020), Pellam Bridge Construction, Access Management, and Roadway Name. Commissioner Constance discussed Tier 2, Port Charlotte Beach Pool (2020 Tier II), GC Herring Park (2020), Pellam Bridge Construction, Roadway Name, Edgewater Expansion Design, Taylor Road sidewalk, Water Quality Infrastructure Sales Tax (2020) Budget \$7,000,000, Sales Tax (2020): Ackerman Septic to Sewer Project, and Midway North Septic to Sewer Project. Commissioner Deutsch mentioned Port Charlotte Beach Pool (2020 Tier II), Fire Stations 3, 6, and 17 (2020), William R.
