Charlotte County Board of County Commissioners American with Disabilities Act Transition Plan 2013 (2021 Update)

Introduction and Overview


The Americans with Disabilities Act (ADA) of 1990 (Public Law 101.336) extends broad civil rights protection to persons with disabilities in the areas of employment, public services (state and local governments), access to public accommodation (private entities serving the public) and telecommunications. Title II of the ADA prohibits discrimination by public entities (state and local governments) on the basis of disability by making all programs, services and activities accessible to persons with disabilities. In order to accomplish this, the Department of Justice developed regulations requiring public entities to conduct a self-evaluation of the accessibility of its programs and services to determine whether issues of accessibility could be addressed through changes in the way such programs and services are provided. Public entities are obligated to remove physical barriers to accessibility when program changes cannot ensure access to services, programs and activities in existing facilities. Realizing that structural changes would take time and money to provide, the Department of Justice Regulations, Federal Register 28 CFR Part 35 state that "in the event that structural changes to facilities will be undertaken to achieve program accessibility, a public entity that employs 50 or more persons shall develop a Transition Plan setting forth the steps necessary to complete such changes." This Transition Plan is developed via a self-evaluation of all facilities and programs accessed by the public. This Plan is to be reassessed on a periodic basis and updated as facilities and programs are added, removed, renovated, etc.

Charlotte County's initial Transition Plan was completed in 1995 with updates made in 1996, 1999, 2013, 2015, and 2016. This current re-evaluation is to update the existing plan and to make it more comprehensive as the original plan did not include all parks and amenities. In addition, due to Hurricane Charley in 2004 many of the buildings and facilities listed in the original Transition Plan are no longer present as they were removed and/or replaced.

This Transition Plan contains the required four elements as set forth in Title II:

- 1. A list of physical barriers in a public entity's facilities that limit the accessibility of its programs, activities or services to individuals with disabilities
- 2. A detailed outline of the methods to be utilized to remove these barriers and make the facilities accessible.
- 3. The schedule for taking the necessary steps to achieve compliance with Title II.
- 4. The name of the official responsible for the plan's implementation.

This Transition Plan is available to the public for inspection and participation in its development.
