Dear Mr. Quick:

The purpose of this letter is to officially notify you that the Florida Department of Transportation (FDOT) will be holding a public hearing for the U.S. 41 Project Development and Environment (PD&E) Study from Enterprise Drive to S. Sumter Boulevard. The hearing will be held on Tuesday, March 23, 2010, at the George Mullen Activity Center, 4956 City Center Boulevard, North Port, Florida. A map showing the location of the hearing is enclosed. The public hearing will begin as an open house from 6 p.m. to 7 p.m. with the formal hearing commencing at 7 p.m. Similar notices are being sent to all property owners within 300 feet of the project and to public officials, organizations, and individuals concerned with the project.


The hearing is being held to allow persons an opportunity to express their views concerning the location, conceptual design, and social, economic, and environmental effects of the preferred alternative. The proposed improvements to U.S. 41 consist of widening the existing four-lane roadway to a six-lane roadway from Enterprise Drive to S. Sumter Boulevard. The environmental studies of the corridor will help in identifying a strategy to eliminate or lessen the environmental impacts of the build alternative.

The Draft Project Development Summary Report, environmental documents, and other pertinent information developed by the department will be available for public review weekdays from Tuesday, March 2, 2010, through Friday, April 2, 2010, at the FDOT District One Office, 801 N. Broadway, in Bartow, Florida as well as the Planning, Zoning & Engineering Department at the City of North Port, 4970 City Hall Boulevard, in North Port, Florida and the Mid-County Regional Library, 2050 Forrest Nelson Boulevard, in Port Charlotte, Florida. These materials will also be available at the hearing site from 6 p.m. until the end of the public hearing. Persons desiring to submit written statements and other exhibits in place of, or in addition to, oral statements, may do so at the hearing or by sending them to Mr. Aaron Kaster, FDOT District One, P.O. Box 1249, Bartow, Florida 33831. All exhibits or statements postmarked no later than April 2, 2010, will become part of the public hearing record.

Directions to Public Hearing at George Mullen Activity Center:
From U.S. 41 / Tamiami Trail, turn right on S. Sumter Blvd. Head north on S. Sumter Blvd. for 2.6 miles and turn right on City Center Blvd. into the George Mullen Activity Center parking lot. The hearing will be held in the gymnasium.
