1. Public Hearing to Consider Approving Final Assessment Resolution for Ackerman Sewer Expansion Project MSBU RES 2019-153

Craig Rudy, Utilities Director showed Save Our Water 2019 Opening Video, gave an overview on Objectives, Water Quality, Impaired Waters, Board of County Commissioners (BCC) Focus Area Goals, Septic Conversion Program, Ackerman Sewer MSBU Area, Water Project, MSBU Methodology, Septic to Sewer Cost, Water Capital Cost, Project Status, and responded to Board inquiries.

COMMISSIONER CONSTANCE MOVED TO CLOSE THE PUBLIC HEARING, SECONDED BY COMMISSIONER TRUEX

Chair Doherty spoke to State law, monitoring, water quality, Ackerman area, septic systems, on site treatment and disposal systems, and nitrogen loading. Commissioner Constance noted start and finish dates, Harbor Boulevard, road portion, assessment, funding sources, guaranteed maximum price (GMP), Charlotte County Utilities (CCU) financial stability, Utility meetings, bonds, aging system, East Port water treatment, spills, Dr. Reeves Workshop presentation, septic systems, Workshop, Ackerman Waterway, nitrogen, General Development, new systems, aerobic treatment units (ATU), sea level rise, coastal areas, Spring Lake, North Shore, Cape Coral systems, cost, Resources and Ecosystems Sustainability, Tourist Opportunities, Revived Economies of the Gulf Coast States (RESTORE) Act, State Revolving Fund (SRF), and State and Federal funding. Commissioner Deutsch mentioned oath, study, Peace and Myakka Rivers, sewers, nitrogen, septic systems, time life, cost, and property value. Commissioner Tiseo discussed aerobic system, Florida Statute 381.00655 Section 1(c), performance based systems, variance, 2016 election, Spring Lake sewer project, sewer expansion program, regulatory agencies, permits, sewage

treatment plant, canal dredging, density, CCU, General Development, spills, system failures, technology, cost, funding sources, deferral program, Unity of Title, Charlotte County permit report, septic repairs, water quality, nitrogen, red tide, blue green algae, nitrogen reducing system, Environmental Protection Agency (EPA), test wells, fees, assessment, and MSBU. **Commissioner Truex** commented on utility repair and replacement, nutrients, EPA requirements, high water mean, studies, fecal coliform, Spring Lake, red tide, algae bloom, Captains for Clean Water, fishing industry, removal system, Department of Environmental Protection (DEP), Department of Health (DOH), fertilizers, and Ordinances.

Marilyn Miller, Assistant County Attorney responded to variance, Municipal Service Benefit Unit (MSBU), assessment, connection, and benefit.
