BOARD OF COUNTY COMMISSIONERS

SEPTEMBER 7, 2022

A Public Hearing on Proposed County Budget Fiscal Year 2022/2023 was held at the Murdock Administration Complex in Commission Chambers; Room 119, Port Charlotte, Florida.

The following members were present: Chair Truex, Commissioner Constance, Commissioner Deutsch, Commissioner Doherty, and Commissioner Tiseo. Also in attendance were: County Administrator Flores, County Attorney Knowlton, and Minutes Clerk Johnston. The following members were absent: None.

The Meeting was called to order at 5:01 pm, followed by the Pledge of Allegiance.

County Administrator Flores highlighted budget and goals.

Gordon Burger, Budget and Administrative Services Director gave a brief overview of Agenda.

2. Millage Rates

Mr. Burger gave a brief overview of Assessed Valuation, Fiscal Year (FY) 2023 Property Valuations, Neighboring Counties, Revised Ad Valorem Revenues, Ad Valorem Variance, Valuation Impact on Homestead Tax Bill, Residential Permits, Number of Units Sold Per Calendar Year, Real Estate Transaction in \$ Per Calendar Year, Mean & Median of Residential Transactions, Homestead Tax Valuation, How Your Tax Dollar is Spent FY 2022/2023, Millage Rate Scenarios, Revised Ad Valorem Revenues, Undesignated Revenue, Public Safety Fund, Option Impact on Homestead Tax Bill, Sheriff Capital Fund, Capital Projects Fund (10 Year Projection), Street Lighting, and Street Lighting District.
