Vaccination tally in Charlotte County tops 21,000

The Department of Health vaccination effort in Charlotte County continues with more than 21,000 vaccinations administered as of Feb. 10, including more than 6,000 who have completed their two-dose series. To view the latest vaccination update, visit tinyurl.com/FLvaccinations. The tally is updated daily.

Nearly 100,000 people have pre-registered for vaccine appointments and information on



the myvaccine.fl.gov website or by calling 866-200-9160 (or 833-990-3549 for TTY users) since the system was launched two weeks ago. Some of that number is likely a result of residents registering by both methods.

People who have received their first dose can get their second dose between 1 p.m. and 3:30 p.m. on the date listed on the back of the card received when the first dose was administered.

Those who received a first dose elsewhere must register for a second dose in Charlotte County via the call center or website or get their second dose where they received their first dose. An additional distribution location was announced this week at the Winn-Dixie pharmacy, 4100 McCall Road in Englewood. Visit www.winndixie.com/pharmacy/ covid-vaccine.



Health Benefit Costs



Charlotte County opened an Employee Health Center in 2008 as way to control health care costs and maintain a quality benefit for our employees. Since that time we have opened an additional site and added a Wellness component.


The graph below demonstrates the significant success of this program. For the last ten years our health benefit costs per employee have increased an average of 1.5% per year. For the same period of time the national average annual increase was 6% and the state average was 9.5%. The cummulative projected savings for that period between the national trend and our experience is \$67 million and over \$106 million when compared to the state trend.









Murdock Village Gateway Lots

Last year, CRA owned Gateway lots in Murdock Village were identified and adjacent owners were contacted due to the potential to create assemblages of commercial property (CG Zoning) within Murdock Village CRA Gateway area. Last month the Board of County Commissioners approved the sale of 4 Gateway lots to an adjacent property owner and the exchange of 2 lots with an adjacent property owner to provide property assemblage that will maximize the potential of these commercial properties. Recent Accomplishments

- Carpet was replaced with LVT throughout the East Port Wastewater Treatment Plant Operators Command Center providing better durability while reducing maintenance in this area.
- The records room in Grace Street Annex was recently renovated. The renovation consisted of removing &



reconstructing walls, removing an abandoned filing system, installing new flooring, and painting.

 Tampa Bay Rays funded phase II renovations were finished at the Sports Park. Major and minor league areas were remodeled to include a new meeting room, offices, and renovation of the locker space & training area.

Fire Station 9

January 2021

The county in support of Babcock Ranch Master Development Order implemented the Emergency Management Services Substation 9 project. The project scope included living quarters for EMS staff, isolated personal protective equipment storage area, and covered area for the apparatus. The substation is located on a leased property in Babcock Ranch. The ADA ramp was installed on the modular trailer with the paving, landscaping, and apparatus shelter constructed. The commercial power connection is scheduled for mid February with project completion expected the end of February. Staff is projected to occupy the substation in March.

Forward Progress

• Construction began on the retrofit of sports lighting to LED at Franz Ross Park. The



tennis courts are substantially complete with construction continuing at the football fields.


- Staff received the Fire Stations 2 & 5 Guaranteed Maximum Price from the construction manager. Purchasing is processing the GMP for Board approval.
- Family Services Center Phase I has reached the 50% construction completion milestone. Interior drywall and exterior stucco are underway.
- The Airport Rescue & Fire Fighter simulator project bid plans were received. Wharton-Smith started the bid process creating the Guaranteed Maximum Price due the end of February.

Notable Happenings


- Furniture was ordered for the two new courtrooms, including jury and judge's support spaces, that are nearing completion at the Justice Center Renovations project.
- A kick-off meeting was held for the Utilities Audit which includes an audit of the last three years' utility billings for the Murdock Administration Center, Justice Center, and Jail.
- An initial site walk was conducted to determine the best location for the generator at the Harold Avenue Recreation Center.
- The Board of County Commissioners approved the Guaranteed Maximum Price (GMP) for construction of the new Charlotte Transit Facility that will be constructed by Wharton-Smith using federal grant funds.



COVID-19 Vaccinations

It is safe to say that COVID-19 vaccinations have been one of the primary focuses of Public Safety during January. Emergency Management has been leading our county's pandemic response and supporting the Department of Health effort to protect our citizens.

During January, Public Safety evolved from supporting COVID-19 testing sites to supporting COVID-19 vaccinations at the Harold Ave. Rec Center. While many have been vaccinated, the demand for the vaccine remains great while the supply of vaccine doses is low.

January saw the method of getting a list of qualified vaccine recipients evolve as well. Early on, when the county received a supply of doses, the public was notified, and a local non-profit opened their website for appointment. The volume of folks trying to register often crashed the site, leading to frustrated citizens and sometimes offered more appointments than available.

Next, the state provided a phone registration system to help counties get qualified vaccine recipients on a list. A few days later, the online



version went live, allowing individuals to sign up and get on a waiting list. The system will then notify those waiting once the vaccine is



available. In a few days, 96,000 had joined the list.

Public Safety, as well as all county staff, remain committed to helping as many people as possible receive the vaccine as soon as we possibly can. CHARLOTTE COUNTY FLORIDA Public Works

In the Works

Emil Sweptson Bridge Repairs are scheduled to begin on January 25, 2021. This project is a 60-day contract, scheduled to be complete on March 26, 2021. The project includes expansion joint repairs, clean and seal bridge deck and sidewalks, approach guard rail replacement, replace sidewalk

approach slabs, replace portions of sidewalks, replace existing rip rap at end bent, mill asphalt pavement, install new

asphalt pavement, replace pavement markings.



Did You Know

A semi-truck accidentally hit a fire hydrant while turning the corner into Cheney Brothers Inc. The water



from the hydrant caused the ground to become unstable and when the semitruck drove over, the ground opened into a sink hole. Our crews have backfilled and compacted in 8 - 12" lifts with a shell and gravel mix to ensure we have a stable base material that will support the scheduled asphalt repair. Our contractor for this project will be making the necessary repairs.

Working Together

Charlotte County Public Works Department personnel set up the Charlotte County Department of Health Covid-19 vaccination site prior to the start of vaccinations on Dec. 30. Public Works Department personnel coordinated with the Office of Emergency Management, Community Services, and the Department of Health to devise the traffic management plan to ensure an orderly and convenient process for citizens to receive

vaccinations at their appointed times.
