

# Family Services Center to Open in Parkside

Phase 1 of the Family Services Center will open in the Parkside neighborhood by the end of September. The project was funded by the voter-approved 1% sales tax.

The Neighborhood and Intake Services Divisions will be the first to move in August and will be joined by six other local organizations or agencies: The Boys & Girls Club, Charlotte Behavioral Health, Charlotte County Sheriff's Office, Jewish Family and Children's Services, Florida Department of Health, Charlotte Alliance for a Safe and Drug Free Community and the Hearing Impaired Persons of Charlotte County.

# FEMA flood rating changes begin Oct. 1

The National Flood Insurance Program is implementing a new phased methodology for rating flood insurance policies. This will affect many flood policies in Charlotte County. The new methodology will enable the Federal Emergency Management Agency to deliver rates that are actuarily sound, equitable, easier to understand and better reflect a property's flood risk.

New policies beginning Oct. 1, 2021, will be subject to the new rating methodology. Existing policyholders eligible for renewal will be able to take advantage of immediate decreases in their premiums.

All remaining policies renewing on or after April 1, 2022, will be subject to the new rating methodology.






#### Workers Comp & Safety



### **Family Services Center Phase 1**



A Certificate of Occupancy was issued on August 5, 2021 finalizing the construction of the new Family Services Center facility. A 2014 Tier 1 sales tax project, the Family Services Center began design in August 2019 and completed design in July 2020. Construction followed in September 2020. The project will continue with demolition of the existing building, and the contract for construction will be completed in December 2021. The new facility is a replacement of the existing building located on the same property. The new building was programmed at 17,410 sf and will offer space for Human Services' 211 Division, lease space for community partners, a teaching kitchen, and temporarily youth services. The project officially became Phase 1 when Phase 2 of the project was approved as a 2020 sales tax project by voters this past November. The new Phase 1 facility benefits the citizens by offering a central combined location to provide multiple resources to the community.

### **Progress**


- The Construction Manager at Risk shortlisting for the Family Services Center Phase 2 is complete, with Board approval of first-ranked Tandem Construction scheduled in September. Contract negotiations are complete for design with Fawley Bryant Architects.
- Progress on the new Transit facility includes exterior stucco completion, sewer line installation, and 80% completion of water control structures. Interior space is 70% complete with drywall and all windows installed.

### Fire Station 10 progress includes




installation of the kitchen hood, interior insulation and drywall, exterior stucco, and generator. Permanent power will be connected soon, and the propane tank installed.





# Growth

Charlotte County Fire & EMS has several building projects underway. Three stations and an ARFF (aircraft rescue & fire fighting) training facility are all under construction. Station 10 on Don Pedro Island is scheduled to be completed in Nov. The new station will replace the current aging station and will provide room for future growth. The new building is being built to current hurricane standards and is rated to withstand a category 5 hurricane. If Emergency Management orders an



evacuation of the barrier islands due to a storm, our crews will leave the island like everyone else. When the all-clear is given and the storm has passed, we will be able to return and quickly resume emergency services to the island's residents. The new Station 5 is being built on Burnt Store Road and will provide coverage to the growing number of residents moving to the south Burnt Store Road area near the county line. Station 5 and

Station 2 are both scheduled for completion by early 2022. Station 2 is being built just up the road from its current location. The new



station will easily accommodate future station growth needs and be able to serve the community for years to come.

The ARFF training facility is under construction at headquarters. The training facility will allow our staff to meet FAA training requirements without traveling across the state. Our county will also become a destination for other departments who need to satisfy their training needs. # In the Works

Our contractor is paving Atwater Street as part of the FY21 Road and Bridge Paving program. This program officially started on July 19th, 2021. When the Road and Bridge Paving program is complete, approximately 19.9 miles of road and bridge roadways will be repaired and resurfaced. This includes CR-74 (Bermont Road), Winchester Boulevard South, Atwater Street, Olean Boulevard, Chancellor Boulevard, and Hillsborough Boulevard.



# Did You Know

What started off as a small depression off Bermont Rd. turned into a big project for the team. The joint of the pipe underneath the road was leaking which created the dirt around the pipe to sink. Our maintenance and operations teams went out to the site and cut the road around the hole to investigate. They excavated around the pipe to locate the leak, wrapped the pipe and repaired the joint, then they filled the hole with asphalt and paved the road.



# Working Together

Jeff Keyser, the Project Manager for the Olean Boulevard Widening Project, had a visitor at the project site. Arvin has been watching the construction from the start and had some questions for the Project Manager. Jeff met with Arvin and discussed the variety of construction equipment used onsite and the different construction methods used to construct the project. 

# **UNDER CONSTRUCTION**

 Ackerman Septic to Sewer Project: Construction of a wastewater system to service approximately 2,135 properties with sewer service. Zones 1. 2 and the vacuum station are currently underway. Crews have started on the water main replacement along Ackerman Avenue. Residents may experience low pressure while crews are testing and flushing the new water lines. Staff is constantly monitoring the water quality and it is safe for consumption while this work is occurring. For project information:

### Deep Creek Sewer Force Main Replacement:

Construction of a larger sewer force main to improve transmission capacity for the Deep Creek neighborhood. This project also includes pumping improvements at several lift stations along the project route. Crews are restoring the easements and roadway crossings along Rampart Boulevard.

### • El Jobean Septic to Sewer Project:

Construction of a wastewater system to service approximately 300 properties with sewer service. On-site sewer connections for Phase 2 have started. Residents will receive a door hanger approximately one week before the connection of your home. Phase 1 connections are expected to begin next month.
