Policy Statements

Economic Development

- **Support** state funding that allows for creative approaches for local government partnerships with K-12, technical and post-secondary educational institutions in the creation of job training programs and innovation clusters that increases economic development opportunities.
- **Support** continued funding of the Florida Job Growth Grant Fund that provides critical funding for necessary infrastructure and workforce development projects that support economic development in Florida.
- **Support** legislation and appropriation that enhances the efficiency and effectiveness of the state and local government partnership in economic development through the greater use of targeted strategies and strategic investments to induce and retain sustainable economic activity resulting in a consistent positive return on investment for both state and local governments.
- **Support** legislation that would enhance the current incentives program to support and incentivize local governments to create and maintain a more sustainable and competitive physical and financial environment for attracting film, television, digital and new media related entertainment production in the State of Florida that promotes and is tied to infrastructure and workforce education in science, technology, engineering, arts and math.
- **Support** efforts to maintain or increase funding for local government affordable housing programs.
- **Oppose** effort to sweep the Local Government Housing Trust Fund and the State Housing Trust Fund that provides needed funding for affordable and workforce housing.

Budget, Taxation & General Government

- **Seeking** reauthorization of both the Hurricane Loss Mitigation Program (HLMP) and Hurricane Shelter Retrofit program.
- **Support** legislation and measures to clarify language in the 2019 CS/CS/CS SB 426. The bill requires greater administrative guidance on its scope and funding mechanisms to best assist firefighters and local governments in accomplishing its intent.
- **Request and support** state legislation that addresses the 2019 (SB 1666) Derelict Vessel Grant Program changes, specifically the way vessel registration moneys designated for use to counties are distributed by Fish and Wildlife Conservation Commission (FWC).
- **Support** measures that enhance the effectiveness of existing local revenue sources to meet current and future public service demands.
- **Support** methods to enable local efforts to collect due and payable local taxes, fees, fines and other revenues.
- **Support** continued state efforts for tax reform provided that such efforts remain revenue neutral for local government.
- **Support** continued revision to current law regarding the Communication Services Tax in a manner that is: 1) revenue neutral; 2) simplifies administration and collection of the current tax; 3) provides for a broad and equitable tax base; 4) provides for enhanced stability and reliability as an important revenue source for local government; and 5) provides the opportunity for market-based growth.
- **Support** legislation that would phase-in a reduction and eventual exemption of state sales tax on commercial leases, but preserving and “grandfathering-in” existing local (county) option sales taxes.
- **Support** legislation authorizing collection of state and local discretionary sales tax on remote internet purchases.
- **Support** an increase in funding for the State Aid to Libraries grant program which provides critical matching grant funding for operations to expand the capacity of digital and print resources of local libraries.
- **Support** legislation that allows senior staff to participate in executive sessions as subject matter experts to provide board members with technical knowledge necessary to make informed decisions.
- **Oppose** shifting costs for state programs to local governments without a permanent identified funding source.
- **Oppose** any efforts that seek to modify or weaken the powers and duties of local governments granted under Chapter 125 & Chapter 200, Florida Statutes.
- **Oppose** the City of Punta Gorda’s 2021 Legislative Request to become the “principal partner” and owner of the Punta Gorda Airport. We support Chapter 2011-263 Section 19, which states “If for any reason, the authority shall terminate, be terminated, or cease operation or existence for any cause or reason, then, upon such termination or cessation, title to all property, real, personal or mixed, tangible or intangible of whatever kind, and wheresoever located, shall immediately vest in the county, which by and through the board, is hereby authorized to exercise any and all powers herein granted to the authority for the purposes herein expressed.” We understand our statutory responsibility and we will assume that responsibility.

- **Support** maintaining the current structure, elective process, and representation process of the Charlotte County Airport Authority. Additionally and explicitly, the Charlotte County Board of County Commissioners supports the Charlotte County Airport Authority pursuit to Chapter 2011-263 Section 19 which states “If for any reason, the authority shall terminate, be terminated, or cease operation or existence for any cause or reason, then, upon such termination or cessation, title to all property, real, personal or mixed, tangible or intangible of whatever kind, and wheresoever located, shall immediately vest in the county, which by and through the board, is hereby authorized to exercise any and all powers herein granted to the authority for the purposes herein expressed.” We understand our statutory responsibility and we will assume that responsibility should the need arise.
- **Support** legislation that addresses problems and abuses within the state of Florida’s PACE program specifically, but not excluding requiring the PACE program to include greater consumer protections and awareness, and/or requiring financing be based on the ability to pay, reviewing, and requiring program adjustments to prevent contractors from unjustly marking up prices of services and penalties for paying off loans early. Also, requiring the Florida Attorney General’s Office begin reviewing and investigating PACE program contractor issues for potential fraud and abuse.
- **Support** the Charlotte County Airport Authority (CCAA) request for \$3 million in State funding for a new combined hangar and classroom facility for Charlotte Technical College’s (CTC) FAA-certified Aviation Maintenance Technician School. CCAA will construct the facility and enter into a long-term lease with County Public Schools (CCPS) whereby CCPS will occupy and maintain the facility at the land-lease rate.

Natural Resources & Growth Management

- **Support** funding request for the Charlotte County Central Sewer Expansion project which includes constructing central wastewater service to 1,933 properties with aging and failing On-Site Wastewater Treatment and Disposal Systems (septic tanks) that are contributing to the pollution of the impaired water bodies of Charlotte Harbor, the Peace River and the Myakka River.
- **Support** funding for construction of a new operations facility. The West Coast Inland Navigation District plan is to construct a new 4,500 square-foot operations facility in Sarasota County. This new facility will provide much needed agency-specific public meeting space and office space for employees with room for future growth.
- **Seeking** state cost share to complete the Stump Pass Inlet Management Plan.
- **Continue and expand** annual funding for the Coastal & Heartland National Estuary Program, including recurrent dedicated funding.
- **Support** increased funding of Florida Forever and Florida Rural and Family Lands programs.
- **Support** dedicated for ongoing water quality monitoring. **Support** funding for committed water quality monitors in specified areas across Charlotte County.
- **Seek** funding requests for real-time water quality monitoring for the Peace River, Myakka River, and Charlotte Harbor.
- **Support** the funding of the Water Protection and Sustainability Program within the Department of Environmental Protection and Water Management Districts for the development of alternative water supplies, water quality improvement projects, and comprehensive water infrastructure needs.
- **Support** legislation that enhances regional and local financial capability to address water supply development with allocation flexibility in all available funding sources.
- **Support** legislation that requires or incentivizes property owners to connect to reclaimed water lines when such lines are available and efforts to limit the issuance of permits for use of ponds and wells on sites where reclaimed water lines are available.
- **Support** a balanced distribution of funds for land acquisition and for water quality and quantity projects throughout the state, with equitable allocation irrespective of a project's urban or rural nature, or its coastal or inland location.
- **Support** legislation to amend Section 159.17, Florida Statutes, to authorize counties – as well as municipalities – that issue revenue bonds, to place liens that are prior to and on parity with state, county and municipal tax liens, on properties served by any water, sewer or gas systems for service charges until paid in full.
- **Support** legislation that allows a county to opt out from mandatory membership in a regional planning council.
- **Support** legislation that allows coastal communities to levy the 6th cent of Tourist Development Tax to support the local share of beach renourishment where critical erosion exists.
- **Support** a statutory change to Section 163.3178 that clarifies for state and local officials how risk reduction is evaluated in special flood hazard areas (SFHA), as shown on FEMA Flood Insurance Rate Maps (FIRMs).

Health & Human Services and Healthcare

- **Support** continued funding for community-based free and charitable clinics that provide emergency room diversion and basic safety net health services for the uninsured and indigent.
- **Support** increased funding for core mental health and substance abuse services.
- **Support** legislation that repeals the state statutory preemption of smoking regulation by allowing local governments to enact local regulations that exceed state standards. In lieu of a total repeal of the preemption, **Support** legislation granting local governments the authority to restrict smoking in areas where children are present.
- **Support** efforts to increase supportive housing, employment and education initiatives for people with behavioral health issues and/or disabilities.
- **Support** diverting, medically assisting, or treating mentally ill persons outside of the criminal justice system through alternative community programs, such as Crisis Intervention Teams.
- **Support** providing life-saving interventions, medically-assisted detoxification programs, and diversions from the criminal justice system for those suffering from opioid addiction.
- **Support** establishing a cap on growth in the individual county Medicaid costs under s. 409.915, F.S. to address the cost shifts that result from the transition to a Medicaid enrollee based cost-sharing system.
- **Oppose** any efforts to sweep the Sadowski housing trust fund which provides critical funding for affordable housing.

Transportation & Infrastructure

- **Seeking** funding for the county's security infrastructure. This project will unify the 12 platforms into 1, upgrade antiquated infrastructure, and provide the county with a security standard and framework for future buildings and capital renewal. The project will also identify physical security alterations needed within highly populated county buildings to protect county staff, residents, and visitors from potential threats.
- **Support** designating, I-75 within Charlotte County as a Purple Heart Highway Initiative.
- **Seeking** funding for modernization of the Charlotte County Justice Center.
- **Support** funding request for the expansion of recreational facilities at the William R. Gaines, Jr. Veterans Memorial Park that will honor the memory of Corporal William R. Gaines, Jr, all Veterans and first responders. Corporal Gaines was a local resident of Charlotte County who was killed in the line of duty in the October 23, 1983 bombing of Marine barracks in Beirut during the Lebanese Civil War.
- **Support** funding for the G.C. Herring park which will provide multi-generational outdoor recreation activities including a new playground, multipurpose field a fishing pier and nature trail.
- **Support** efficient and effective government by reducing the requirement for mandatory independent construction engineering and inspections (CEI) services on projects that have less than 50% in state funding.
- **Support** a restructure of the formula and methodology used in the distribution of gas tax funds and a review of the methodology of state prioritization (criteria) and funding for transportation projects.
- **Support** a review of state criteria for roads to be designated SIS (state roads). Charlotte County believes there are roads within our jurisdiction that meet the criteria and should be designated state roads as a part of the SIS.
- **Support** funding for Building and construction for the William R. Gaines Jr. Veterans Memorial Park-Beirut Peacekeepers Memorial Tower.

Public Safety

- **Seeking** funding for the county's utilities communication and cybersecurity infrastructure.
- **Request** Sunshine law exemption for County elected officials to be able to discuss emergency related issues during a local state of emergency.
- **Support** funding sources for the Charlotte County Sheriff's office law enforcement body camera program.
- **Support** public records legislation that exempts the home addresses of security personnel, county administrators, and county attorneys. Reducing the likelihood of further security issues is a county priority.
- **Support** public records legislation that exempts security "operations" meetings.
- **Support** public records legislation that allows for the aggregation of public records requests.
- **Support** public records legislation that allows for designation of a public records request official.
- **Support** public records legislation that allows for online public records request to be responded to with county website with requested information.
- **Support** funding for Charlotte County Fire EMS to enhance our ability to clean contaminated fire gear after every fire.
- **Support** long-term and stable funding for the Clerk of Courts.
- **Oppose** legislation that limits the ability of county EMS providers to be reimbursed for out-of-network transports.
- **Support** maintaining a countywide regulatory system for EMS through the current Certificate of Public Convenience and Necessity (COPCN) process.
- **Support** efforts to stop opioid trafficking and increased penalties for dealers and traffickers whose actions result in loss of life.
- **Support** legislation that reduces jail expenses by setting a reimbursement amount paid by counties to medical providers for health care services for inmates and arrestees at no higher than the established Medicare rate plus 10%, the same rate as currently charged to the Department of Corrections, unless there is an existing contract in place or a business practice providing a lower rate.
- **Support** continued efforts to obtain Medicaid eligibility for persons incarcerated in county jails while waiting disposition of their cases and to ensure that existing Medicaid benefits are not terminated during incarceration (fed and state).
