MINUTES

January 5, 2023, at 9:00 A.M.

1. Call to Order:

Don McCormick called the meeting to order at 9:00 a.m.

2. Pledge of Allegiance

Don McCormick asked those in attendance to stand for the Pledge of Allegiance.

Mr. McCormick welcomed Robert Wibbeler, District 1, to the board and had him speak about his background.

Mr. Killion stated he has sent his application in and is waiting for it to go in front of the board. Mr. Killion also commented that the Charlotte Harbor Regatta for 2023 is canceled.

- Brandon Moody, Water Quality Manager
 - Water Quality

Mr. Moddy gave a short update on the water quality that he did a presentation on at the November 15th, 2022, BCC workshop. The presentation can be found on the Charlotte County Website at CHARLOTTE COUNTY BOARD OF COUNTY COMMISSIONERS (charlottecountyfl.gov)

Stas Matias and Nichole Beyer arrived at 9:08 A.M.

Damion Ochab asked if the data points inclusive of the hurricane results? **Mr. Moody** replied no, these are samples that have been sampled monthly before the hurricane.

Ms. Lang inquired if CHNEP data's will also be included to website data? **Mr.** Moody responded the plan is to contribute our data to CHNEP and they will have everyone's data.

There was a short discussion about budgets.

Riviera Marina

Mr. Moddy commented that there was a settlement pending sale of the property to the new owners. They were looking to close in September, however the storm delayed things. There has been communication between Florida Department Environmental Protection (DEP) and the lawyers. They are looking to close the sale within the next month or so. Once new ownership takes place, the DEP will move forward for cleanup and all. He was out by the Marina Tuesday after the storm taking samples and documenting boats. The storm definitely made some impacts.

8. New Business

- Parks and Natural Resources
 - Parks and Natural Resources Update

Jamie Scudera updated the members with the final sea turtle numbers; this is within Charlotte County excluding Little Gasparilla Island:

Total numbers that staff documented:

2,020 sea turtle nests compared to last year which was 1,800 nests
Manasota Key total – 1,091 (Greens and Logger Heads)
Palm Island, Knight Island and Don Padro- 686 (Green and Logger Heads)
Boca Grande- 243 (Green and Logger Heads)

Ms. Scudera mentioned that they had a monitor that was interested in this coming sea turtle year on Boca Grande. Staff has been working on mailers for 2,400 beach front property owners to be mailed with light information. This month and next month they will have a USDA trapper out 20 hours for this month and next month. To do some preseason trapping in our shorebird areas around the state parks. The BCC board approved to hire a part time coastal trapper through USDA, who does all of our trapping. Who will focus in areas where there is predation issues.

DV Reports

Ms. Scudera gave an update on the DV report. 16 have been removed. The Hurricane Ian DV boats do not qualify for the FWC Vessel turn in program, which states that the vessel must be floating and not be deemed a

Derelict Vessel. FWC are working with an open understanding with the owners due to the hurricane as far as removal is concern.

Ms. Scudera mentions a podcast that the staff has put together with information about sea turtles and shorebirds. She also comments that staff has been working with 3 different hardware stores within the Englewood area and asked for them to set up a lighting display for sea turtle lighting. To better assist the beach residents.

Damian Ochab, SMSKA, expressed his concern with the board about the gated beach parking that is on the BCC agenda for Tuesday, January 10th. He asked the board to write a letter of opposition or denial for the gate proposal.

There was a discussion about the gated beach parking that is being proposed for Manasota Key beach.

Ms. Lang made a motion for Chairman Don McCormick to write a letter to the Board of County Commissioners stating the board opposes the proposition as it is, seconded by **Ms.** Beyer; the motion passed unanimously.
