CHARTER REVIEW COMMISSION MINUTES OF MEETING July 15 , 2010

A meeting of the Charter Review Commission (CRC) was held at the Administration Complex, Room 106-B, Port Charlotte, Florida

Roll Call

In addition to membership, the meeting was attended by *Robert Berntsson, Esq.*, counsel for the CRC

Call to Order

The meeting was called to order at 4:05 p.m. EDT by Chairman Ken Doherty

Agenda Items:

<u>1.</u> <u>Approval of Minutes.</u> *Chairman Doherty* confirmed that the members had previously been provided copies of the Minutes of the meeting held June 17, 2010. There being no deletions nor additions to these Minutes they were approved unanimously on motion made and seconded.

Chairman Doherty confirmed that the members had been provided copies of the Minutes of the Public Hearing held on July 1, 2010. There were no deletions nor additions to these Minutes and they were approved unanimously on motion made and seconded.

Chairman Doherty confirmed that the members had been provided copies of the Minutes of the meeting held on July 8, 2010. There being no deletions nor additions to these Minutes they were likewise approved unanimously on motion made and seconded.

2. Approval of CRC Expenses Chairman Doherty referred to the invoice from Robert Berntsson, Esq. for services rendered the CRC during June. This invoice had been previously distributed to the membership for their review and a copy is attached to these Minutes as Attachment "A". A motion was made and seconded to approve payment of this invoice. Chairman Doherty then reviewed an updated list of expenses from the last meeting, also previously distributed to membership, a copy of which is attached to these Minutes as Attachment "B".

Chairman Doherty said that there would be no meetings during August and September, the last meeting of the Charter Review Commission to be held on October 21, 2010. *Mr. Doherty* mentioned that there may be statements submitted by Mr. Berntsson during this period, and he asked the membership for permission to approve payment of those statements. There was a motion made to approve this action. *Frank Weikel* amended the motion to say that the Chairman could approve all upcoming expenses subject to the availability of sufficient funds. This motion was seconded and approved unanimously.

3. Public Input: None

<u>4.</u> <u>Commission Comments</u> *Paula Hess* said that she was sorry to have missed voting because of her travel schedule, indicating that she had made her plans based on the original meeting dates. *Chairman Doherty* responded that the decision to move the voting to earlier meeting dates had been a logistical situation. *Ms. Hess* indicated that she had brought in the binder provided each member at the beginning of the session, to be returned for re-use.

Chairman Doherty reminded the members present to mark their calendars for the last regular meeting to be held on October 21, 2010.

Frank Weikel reminded everyone to also bring in their binders to that meeting for recycling.

Robert Berntsson, Esq. updated the membership, indicating that he had spoken with County Attorney Knowlton and the Resolution was on the BCC Consent Agenda for their meeting July 27, 2010. Mr. Berntsson said that he would be attending that meeting but there would be no formal presentation to the Board.

Chairman Doherty said that the Final Report was posted on the website. *Mr. Doherty* added that he had copies of the Report and would be visiting each Commissioner, the County Administrator and the County Attorney with copies of the Report. *Chairman Doherty* then said that it had been a privilege to have chaired the Charter Review Commission. *Mr. Doherty* remarked on the volume of public participation received during this session, adding that the many issues which this CRC decided to examine
