# II. Citizen Input on Agenda Items:

• Richard Russell, Port Charlotte — In favor of single district voting for Commissioners and concerned about the future of water in Charlotte County and the impact of outside agencies that are destructive to our harbor, our livelihood, and our marine life.

- Tim Richie, Punta Gorda Isles Concerned about water quality and especially Mosaic's destructive impact.
- William Kitsch, Punta Gorda Submitted "Right to Clean Water Amendment" proposal and Letter regarding public participation and input suggestions. (attached)
- Ted Ehmann, Murdock Section 1.3 Municipal Ordinances. Recommend amending with language concerning sustainability.
- Cindie King, Gulf Cove In favor of election of CRC Members and Board of County Commissioners district residency.
- David Kalin, Charlotte County Recommends term limits for Commissioners for 3 terms.
- David Kesselring Recommends clean water amendment, single member district voting, elected CRC members, limitation on the power and authority of the County Attorney and County Administrator, and lower percentage for citizen's initiatives.

### III. Old Business:

# a. Sub-committee Reports:

- **i. Administrative Staff:** Chair Barrett reported that the committee met on November 18, 2021 and started reviewing some of the suggestions made by the staff.
- **ii. Board of County Commissioners:** Chair Abbatematteo reported that the next two committee meetings are Dec.  $9^{th}$  and  $16^{th}$  with the five Board of County Commissioners followed by a meeting to discuss the Final Report.
- **iii. Constitutional Officers:** Chair Schafer reported on the issue of enforcement of residency in the Charter that the subcommittee will raise in their Final Report. A discussion ensued between subcommittee members regarding whether to proceed or not with the next meeting date of December 13<sup>th</sup> to discuss the Final Report. Attorney Rob Berntsson advised that if majority of the committee wanted to meet, then the committee would need to meet.
- **iv. Other Boards and Agencies:** Chair Murtha reported that a Draft Report has been written and the members are seeking comments before finalizing the Report. The Final Report should be ready by the end of the month. Chair Murtha raised a procedural question regarding how the subcommittee reports will be discussed. Chairman Dryburgh laid out the following procedure: Once the reports are submitted, at each CRC meeting one subcommittee will review their report and raise their Charter Recommendations. The CR Commission members will then discuss them. The issues will then go on the Master List (along with items raised by the Public) to be voted upon at the March or April meeting. Attorney Berntsson reminded the group that all reports should be sent to the members prior to the discussion for their advanced review. The CR members will know in advance at which meetings and what reports will be discussed.
