# 2014 Program Cash Flow

## Revenues

- Collections to date  
(as of Oct 1, 2019) \$ 120.4m
- *Projected* collections  
(modest ~\$1.75m/mo) \$ 26.0m

**Total Revenue \$ 146.4m**

## Expenses (includes Tier 2 commitments)

- Expensed to date  
(as of Oct 1, 2019) \$ 75.8m
- Encumbered  
(in contracts) \$ 27.8m
- Planned projects  
(FSC, Olean, Trails, Sailing) \$ 22.5m

**Total program = \$ 126.1m**



# Multi-use Trails and Bike Lanes

Budget \$3,800,000



# Olean Blvd



Budget \$13,350,000

Construction begins  
October 21<sup>st</sup>

Starting at US 41 working  
toward Easy St.

Complete ~ summer 2021

# Family Services Center



Budget \$10,647,000

Currently in programming and design.

Construction start anticipated Summer 2020.

# Tier 2 projects

- **Sailing Center at PC Beach Park**

Budget \$918,000; includes covered storage, pavilion, and fencing

Design in progress; construction start fall 2019, complete July 2020

- **Placida Boat Ramp Expansion**

Budget \$7,000,000; new 2-lane boat ramp, parking, restrooms

Design in progress; lengthy permitting; complete by late 2022

# Tier 2 projects

- N. Charlotte Aquatics Center

Budget \$7,500,000; includes 25yd x 50m pool, dive well, facilities  
Construction in progress, complete by April 2020

- Justice Center Generator

Budget \$900,000; provides emergency power support  
To be accomplished via change order to current project at the site.

# Tier 2 projects

## Unfunded Placeholders

- Charlotte Harbor Trails and Wayfinding  
unfunded: \$1,000,000; waiting and see ~ local development
- Toledo Blade Widening  
unfunded: \$2,700,000; wait and see ~ local development

# 2020 Sales Tax Focus Group

- 21 member committee comprised of residents
- Independently facilitated
- Kick-off meeting held August 14, 2019
- 14 of 31 projects reviewed-to-date
- Blind scoring of projects based on established criteria and weighting
- Final ranking of projects scheduled for March 2020

# Call for Proposals

- Accepting applications through October 31, 2019
- BCC will review proposals at December 10, 2019 meeting
- Sales tax focus group will review, score and rank projects selected by BCC for review

# Next Steps and Timeline

Date	Action
<b>March 2020</b>	Focus group to hold final meeting and determine list of projects that will be recommended to BCC
<b>April 2020</b>	BCC to determine: <ul style="list-style-type: none"><li data-bbox="683 568 1045 601">• Length of extension</li><li data-bbox="683 612 1058 645">• Selection of projects</li></ul>
<b>May 2020</b>	BCC to approve ordinance for ballot referendum
