OWNER'S/OPERATOR'S RESPONSIBILITIES

• <u>Vessel Registration</u>: All vessels on the waters of the state must be registered. F.S. 328.48(2) A Vessel must be in good working order, capable of moving and navigating under its own power (motor or wind)

•Boating Safety Equipment: All vessels on the waters of this state shall carry, store, maintain and use safety equipment in accordance with the current USCG requirements.

F.S. 327.50(1)(a)

•Marine Sanitation: Every vessel 26 feet or more with enclosed cabin, or houseboat, or floating structure with enclosed living space shall install and maintain a toilet with storage capability as to prohibit discharge of raw sewage into the waters of the state. F.S. 327.53(1)(2)(3)(4)

•Mooring: All vessels are to be moored in a way as to maintain the submerged lands in its natural condition. F.S. 253.037(1) A mooring light is required in accordance with the current USCG.

•<u>Litter Law</u>: Dumping litter (whether accidental or intentional) is prohibited. F.S. 403.413(4)(b)(6)

PROGRAM HISTORY

Charlotte County Board of County
Commissioners approved an amendment in
2007; revised in 2015, section 3-9-76.1 of the
Charlotte County Code of Ordinances
concerning the discovery and disposition of
vessels that are abandoned, derelict, a hazard
to navigation, or a health hazard to the public.
This code change allowed the County to assist
in the removal of abandoned vessels under
Florida Statute 705.103(2)(b).

Charlotte County with the help of Charlotte
County Sheriff's Office Marine Division,
Florida Fish and Wildlife Conservation
Commission's Department of Law
Enforcement, and the Punta Gorda Police
Department's Marine Section patrols to keep
Charlotte County Waterways open and clear
for all to enjoy.

WHAT IS A DERELICT OR ABANDONED BOAT

"Derelict vessel" means any vessel, as defined in F.S. <u>327.02</u>, that is left, stored, or abandoned in a wrecked, junked, or substantially dismantled condition upon any public waters of the state, F.S. 823.11 (1a)

"Abandoned vessel" means any vessel that meets the above and not having a identifiable owner and has no apparent intrinsic value to the owner, F.S. 705.101(3)

"At-Risk" means any vessel unable to dewater itself, open hatches, broken loose of its anchor, and no effective means of propulsion. F.S. 327.4107



REPORT AN ABANDONED VESSEL

If you encounter a boat that cannot function under its own power or appears to have been abandoned on or under the water, please let us know by calling Natural Resources or the Sheriff's Nonemergency number at 941.639.2101. Providing these details will help to start the investigation:

- · Vessel description (type, size, make)
- · Vessel location (address, GPS)
- · Registration numbers or vessel name
- · Pictures
- · Why you believe it is abandoned (an ugly boat is not necessarily abandoned)
- · Your contact information



PROTECTING YOURSELF

If you move or sell or donate a vessel to another party, and the change is not recorded to the Department of Highway Safety and Motor Vehicles (DHSMV), you may be held responsible for all damages and costs for the removal of the vessel, if it is later found abandoned or derelict F.S. 705.103 & 823.11 Remember that the transfer of ownership will not occur until the purchaser files for the new title with the DHSMV.

Florida Law requires the seller to notify Department of Highway Safety and Motor Vehicles (DHSMV) about the transaction within 30 days of the sale. F. S. 319.22(2a) 2 (b). **Don't rely on the new purchaser to do the right thing**. You can find the DHSMV 82050 form at the following website:

Click on 82050 form. Both the Seller and Buyer must sign the form. The seller must then submit the form to the Local Tax Collector's Office and keep a copy for your records.
