a. Update: Rampart Boulevard Sidewalk Project: Mr. Slade joined the meeting via TEAMS and provided an update regarding the increased request for design (RFD) fees advising that there is enough money in the budget to cover the increase and we will adjust the Capital Improvement Plan (CIP). Discussion ensued regarding projected construction cost, estimated time frame for design completion, budget adjustments, and future sidewalks. Mr. Slade advised that once the plans get to 60 percent, he will have a better estimate of construction cost and we will investigate potentially another budget adjustment to cover any increases at that time. Questions arose on the possibility of removing the San Cristobal portion of the project and Mr. Slade advised that it would be a minimal cost savings. Discussion went on to discuss Florida Department of Transportations (FDOT) involvement in the portion of sidewalk going over the bridge and Mr. Slade advised that he has not been in conversations yet regarding this project, but that they were involved in past projects and discussed the process in detail. The group had questions regarding the time frame to finish the design and Mr. Slade estimated over a year to completion. Mr. Rossi made a motion asking Charlotte County to move forward with a budget adjustment to complete design of the Rampart Boulevard Sidewalk, the motion was seconded by Mr. Rabinowitz and passed unanimously. There was no further discussion.
