Call to Order / Roll Call:

The meeting was called to order at 10:30 a.m. A roll call was taken, and a quorum was present.

Changes to the Agenda / Motion to Approve Changes:

None

Citizen Input on Agenda Items Only (3 Minute Limit):

 Wayne Harris introduced himself and discussed his concerns regarding the Ohara Waterway and the possibility of considering no wake signs. He also inquired on the possibility of adding additional verbiage on replacement regulatory signs.

Approval of Minutes:

The minutes from March 27,2023, were unanimously approved as written.

Unfinished Business:

- a. <u>Update: Manchester Waterway Dredge Project:</u> Mr. Patchell conveyed that the survey is complete, including Lewis Creek, and he is awaiting deliverables. He stated that final design and review is complete, and the bid package was approved. He explained the bid process and the group will be notified once the project is out to bid.
- b. Additional Slow Speed/Minimum Wake Signage: Mr. Richardson summarized the Florida Fish and Wildlife Conservation Commission (FWC) permitting standards and commented on the need for enforcement. The group was in agreeance and conveyed that they have noticed increased enforcement. Mr. Richardson concluded that additional signage would not be an option and would risk damage to the seabed and tends to confuse boaters. There was discussion regarding permitting and Mr. Richardson explained that our permit is up to date and outlined the guidelines the County follows. Questions arose regarding the possibility of applying for additional signage. The disadvantages regarding the extreme cost, and concerns of the uncertainty of the permit being approved were explained. Mr. Richardson proposed the possibility of placing small plaques under day boards in finger canals and explained that FWC prefers one message, but under certain circumstances they may make an exception.

New Business:

a. <u>Post-storm Bathymetric Survey:</u> Mr. Patchell provided an update regarding the post-storm bathymetric survey and Hurricane Ian impacts. Mr. Patchell reported that a post-storm

- survey was conducted including the Manchester access channel and informed the group that the deliverables have not yet been received. He will provide an update at the next meeting.
- b. <u>Financial Reports:</u> The FY23 quarter two actual expenditure report was reviewed. It was noted that the expenditure's for Public Works is only showing totals up till January 31, 2023. The FY23 quarter one and quarter two monthly funding report (formerly maintenance activity report) were reviewed. There were no inquires.

Citizen Input on MSBU Items (3 Minute Limit):

Wayne Harris suggested the possibility of no wake signs, and it was established that we do
not use this type of signage in Charlotte County. He also inquired on how involved the
Manchester Waterway MSBU is regarding the possibility of opening the Myakka channel. He
was notified that this item does not fall under this MSBU's purview.

Advisory Board Open Discussion:

Conversation ensued regarding waterway debris removal. Mr. Peregoy stated that debris was removed except for some existing boat lifts which are the homeowners' responsibility. Mr. Patchell confirmed the contractor has completed debris removal, but if the group has any concerns, they need to report them to the County as soon as possible.
