- a. <u>FY23 Post storm survey</u>: Mr. Patchell provided the post storm survey results to the group. Discussion ensued regarding the drastic change from the pre storm survey. Mr. Patchell advised the group that this will qualify for FEMA reimbursement and will coordinate with fiscal services and FEMA consultants. Questions regarding FEMA funding, and how the contractor calculates the results of the survey were explained. Mr. Patchell explained the permit process and will update the group as additional information is received.
- b. <u>FY23 Navigational Trimming</u>: Mr. Patchell informed the group that the project is out to bid, and explained what qualifies as a line-of-sight concern, and how he decides locations. The navigational trimming map detailing trimming locations was provided to the group.
- c. <u>Update: Interior Dredge Project:</u> Mr. Patchell advised the group that the contractor has retained written agreements for staging areas and wants to mobilize next week. The project is slated to begin earlier than the anticipated December 4, 2023 notice to proceed date.

Discussion ensued regarding a missing navigational marker, and Mr. Joannes will provide a location for our contractor to address. There was mention of danger signs located at both sides of the bridges in the dirt on Chamberlain Boulevard. Ms. LeMaster will reach out to the project manager to request more information. Concerns regarding children swimming and fishing on Chancellor Boulevard were discussed.
