New Charlotte County Website Launched Aug. 14

Charlotte County launched a new website Aug. 14 that features dramatic aerial video, easy-to-find service functions and a mobile-friendly design.

The website URL, <u>www.CharlotteCountyFL.gov</u>, remains the same, but the modern layout offers expansive drop-down menus that take users to hundreds of webpages to transact online business, find information and report issues to county staff.

"Our website receives nearly 5 million pageviews by 1.25 million users a year, so it serves as the world's window into Charlotte County,' said County Administrator Hector Flores. "The beauty and vitality of the county jumps off the page. The website will reinforce our brand as a premier place to live, work and play, while delivering exceptional service and usability to residents, businesses and visitors."



The new website is designed to be equally functional on laptop, desktop and tablet computers, as well as mobile phones. Menus and features are responsive to devices' screen size and position.

The county contracted with Solodev, a national leader in government website design that has worked with the City of Miami Beach and Seminole and Volusia counties, among others.

Website critical to providing online services during pandemic

Charlotte County issued 217 single family home permits in July 2020, a 15% increase over June 2020 and a 15% increase over July 2019. That's a 78% increase over our lowest month of the year, which was 122 in May.

The industry adapted quickly to submitting permit applica-

tions and plans online when the coronavirus pandemic forced us to close our lobby. Even after it reopened June 1, more than 70% of permit applications are still coming in online.

More than 8,700 reservations have been made at our three county pools for lap swimming and water aerobics since June 1. When our libraries closed, staff launched a curbside pickup service to deliver books to patrons in our parking lots. More than 180,000 items were checked out by 27,737 patrons as of Aug. 1. Even after libraries reopened on a limited basis, this sevice is still a safe, popular option.






COVID-19 Technology Advances

As Executive orders were released daily and even nourly, changing the response efforts, Information Technology, especially Client Services had to shift gears, moving from creating space by moving staff around within county buildings, to an all-out move to a reduction of personnel working in county facilities – creating a home work force. During this time, Client Services mobilized over 290 devices.


Microsoft Teams became a critical component of the mobile work strategy. Teams has enabled staff to continue working together while maintain safe social distancing. 

Allapatchee Shores Park Restoration and Repairs

The park is currently undergoing repairs to the kayak launch ramp, storm water management system, road, and associated infrastructure. This partially grantfunded project was created to not only remedy damages caused by hurricane Irma, but also include repairs to the site. This project is expected to be completed by mid to late November.

Recent Accomplishments

- The Guaranteed Maximum Price (GMP) from Magnum Builders was approved by the Board for the new Fire Station 10 on Palm Island. The contract amendment will be issued followed by construction.
- GMP for Fire Station 9 temporary facility at Babcock Ranch was approved by the Board on July 28.
- The Board approved the Family Services GMP on July 28. The building permit went through initial comments and mobilization for construction will begin in August.



Forward Progress

- Select demolition started at the temporary vacated Public Defender space in the Justice Center. This task is in preparation for the second courtroom construction.
- The final phase of the South County Annex parking lot overlay is progressing with one area completed and second in

progress. The

landscaping installation finishes the scope before completing the project punch list inspection.

restroom repair began in July with mobilization, safety setup, and demo. Rough electric and plumbing kicked off during week 3, and week 4 continued with supply lines, drains, drywall, paint, and partitions reaching basic completion.






Notable Happenings


- Matern Engineering was selected for the generator installation design at Harold Avenue Recreational Center. The FEMA-funded project supports the needs for an emergency shelter.





We Will Survive 2020

A day does not go by where we don't hear a joke or see a meme referring to the challenging circumstances confronting us in 2020. To date, we have witnessed record-setting wildfires in Australia, earthquakes, tornado outbreaks, demonstrations, civil unrest, a contentious election season, murder hornets, and a seemingly never-ending pandemic. As if that list is not bad enough, now the National Hurricane Center has revised its prediction for the 2020 Atlantic Hurricane Season to "Extremely Active." Never before have we entered August with nine storms already receiving names. To put that into some perspective, the average number of storms over the past 40 years is 12. The updated prediction for this season is 24 named storms—just one more stressor in an already very stressful 2020.

All of us would prefer a quiet Hurricane Season, though that may not be in the cards, and we must do what we can now to

ensure we are as prepared as we can be as individuals and an organization. One way to reduce the stress of an active Hurricane Season is to have detailed plans in place now for our families in the event we need to respond to tropical weather. Plans should include having disaster supplies on-hand, knowing how your family will stay informed of the latest deployments, and identifying a location to evacuate if directed to do so; shelters are your LAST option. We will get through this year and come out stronger on the other side.

We encourage everyone to do their part by preparing both themselves and their loved ones this hurricane season. In mid-July, contractor, Marine Contracting Group began maintenance dredging for the Manchester Maintenance Dredge project. MCG is currently dredging out in shoal 1 and shoals 2a and 2b in the Ackerman access channel.

Clean material is being placed as submerged beneficial use in the Humphrey Basin and unsuitable material is being off loaded at the county upland site and will be hauled off to the county landfill.



Did You Know

The county uses 15-foot-wide bat winged brush mowers to maintain the visibility of the right of way for motorists.



The mowers received their nick name because the mowers have a section on both sides of the mower deck that fold up vertically for transport on the roadway.

Mowers working in the right of way pose the same hazards as any other construction equipment. Use the same passing precautions passing mowers as used for other types of construction equipment working in the right of way. Reduce speed when approaching the mowers, and when all is clear, carefully maneuver around the operation.



Construction of a new building for the Myakka Potable Water Booster Station and the El Jobean Vacuum Sewer Station. The booster station will increase potable water pressure to West County at the Myakka River and the vacuum station will provide sewer collection for the El Jobean Septic to Sewer Project.

• Loveland Grand Master Lift Station: Master Lift Station and 48" Gravity Inter-

ceptor, 14,000 LF of 48" pipe and 2.800 LF of 24" pipe. Construction has resumed after a short delay. Crews will be working along Kings Highway and moving east to Loveland Blvd. New anticipated completion is Winter 2021.
