Call to Order / Roll Call:

The meeting was called to order at 2:01 p.m. and a quorum was established.

Changes to the Agenda / Motion to Approve Changes:

Citizen Input on Agenda Items (3-Minute Limit):

Approval of Minutes:

Mrs. Growth motioned "Members Present" be revised to add Stephanie King, seconded by Mr. Ploskina and unanimously adopted. The minutes from February 8, 2023, were approved as revised.

Unfinished Business:

a. <u>Buena Vista Waterway Exterior Dredge Project:</u> Ms. McDonald noted the dredging of the exterior/mouths of the channels isn't anticipated until FY24 based on the timeline from the post-storm survey. Ms. McDonald provided an update from her discussions over the last few months with the County Attorney's Office and Public Works staff regarding the purpose of the unit and funding split for the Elkcam and Sunrise Waterways. Ms. LeMaster presented the revised preliminary 2-year budget and Ms. McDonald pointed out the \$5,000 recommendation to fund navigational trimming has been added. Ms. McDonald reported that no change has been made to the budget yet. Mr. Paolicelli reminded the Advisory Board that regardless of the depth they need, they are paying to keep the waterway open. The Advisory Board agreed that what they pay for dredging is reasonable. Mr. Ploskina reported his research regarding inboard boats and the depth required. Discussion took place regarding boat sizes and the depth needed for different types of boats.

New Business:

a. <u>Financial Reports</u>: The FY23 first quarter maintenance activity report was reviewed. Ms. McDonald informed the Advisory Board that that the quarter two financial reports will be available at the November Advisory Board Meeting.

Citizen Input on MSBU Items:

Mr. Roberts asked why they are paying for the Elkcam waterway.

Advisory Board Open Discussion:

Discussion took place regarding the hurricane waterway debris removal progress; Mr. Paolicelli drew attention to two locations where cleanup is needed. Ms. McDonald explained that they traveled up the Elkcam Waterway two weeks ago. Mrs. Groth pointed out the damage to the Port Charlotte Beach Complex boat ramp, requesting a status of repair. Conversation ensued regarding derelict vessels, and Mrs. Groth was provided information on the derelict vessel removal program and Florida Fish and Wildlife Conservation (FWC) hotline as well as the website to report them.

The Advisory Board unanimously agreed to cancel the August meeting date due to lack of future and ongoing projects. Future meetings are scheduled at 2:00 p.m. in the Port Charlotte Library as follows:
