Call to Order

Mr. Baker called the meeting to order at 1:30 p.m.

An Ordinance of the Board of County Commissioners of Charlotte County, Florida, amending Charlotte County Code Chapter 3-9: Zoning, Article II. District Regulations, by revising Section 3-9-52: Bridgeless Barrier Island (BBI) to allow noncommercial boat docks as permitted principal uses and structures; providing for conflict with other Ordinances; providing for severability; and providing for an effective date. Applicant: Charlotte County Board of County Commissioners.

Mr. Keech, Planner, presented the findings and analysis for Petition **TLDR-25-06** and recommended approval based on the reasons outlined in the staff report.

Questions for Staff

Mr. Vieira asked whether a principal structure is required to construct a boat dock. **Mr. Cullinan** responded that it is not. He referenced an appeal from a month or two ago, noting that the previous requirement had changed with a recent update to the code. Discussion followed.

Mr. Vieira made a motion nominating **Mr. Smallwood** for Secretary, seconded by **Mr. Graham**; motion passed unanimously.


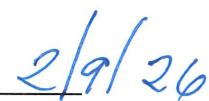
Mr. Baker addressed the vacancy on the Affordable Housing Committee and invited members to volunteer, noting that an application is available to fill the position.
